- Braiding and coats are not necessary. Hard hats with harnesses are required.
- Management reserves the right to split, cancel, or combine classes and add or substitute judges. Classes to be divided JR/SR if warranted.
- Proof of negative coggins required. Limited stabling is available. \$30/day or night. Reservations required.
- Times will be emailed and available on the website [www.fenridgefarm.com](http://www.fenridgefarm.com) no later than Thursday afternoon
- Awards: Six ribbons are awarded for each class and combined tests. **We will offer end of year awards for riders competing in 3 shows.**
- **Refund policy:** After closing date, for Dressage show less \$5 if filled from a waiting list, Full refund for open schooling.
