TN – Training dressage & stadium jumping. Novice cross country 350mpm.

Novice: Large, well built fences, water, ditch and bank, 350mpm.

Beginner Novice: Large, well built fences not to exceed 2'7", pass through water, ditch and bank, 325mpm.

Hopeful Rider: Beginner Novice dressage and stadium jumping, Maiden cross country.

Maiden Division: Inviting fences not to exceed 2' approx 15 solid fences, water optional, no ditch, XC not timed but Stadium Jumping is timed.

First Timers Division: This division has been created to give riders every opportunity to complete a course, have fun and to build confidence. All riders that complete will receive a first place ribbon. Riders may have their dressage tests read to them and may be coached in both cross country and stadium. Riders may make arrangements to have a lead over cross country elements, ALL jumps are optional.

Combined Test - P, T N, BN, M – entries will be combined as warranted.

Dressage only – Test of choice (Eventing or USDF small arena) – entries will be combined as warranted.

ENTRIES: All Horse Trial entries \$100, \$55 for Combined Test, \$30 dressage only. Please make checks payable to **FenRidge Farm**. Refund before closing date minus \$15, after CD minus \$25 if filled from waiting list. Changes and late fee \$10. Competition cancellation: Full Refund. Neg. Coggins within 12 months required with entry.
